



The Devil's Slide Ride, Run and Dog Walk Accident Waiver and Release of Liability

In consideration of being allowed to participate in the Devil's Slide Ride, Run and Dog Walk its related events and activities, I, the undersigned, hereby represent, warrant and agree that:

1. I am in good health. I recognize and acknowledge that The Devil's Slide Ride, Run and Dog Walk is a recreational event that takes place on public and private roads and trails and coexists with traffic. I fully realize the danger of participating in such an event and voluntarily assume all responsibility for loss, damage or injury that may be sustained by me or by anyone I may be in contact with while participating in The Devil's Slide Ride, Run and Dog Walk.
2. As a condition of my entry and participation in The Devil's Slide Ride, Run and Dog Walk, I do hereby forever release and discharge the Partners and Advocates for Remarkable Children and Adults ("PARCA"), their officers, officials, agents, successors, assigns, affiliates, subsidiaries and employees, volunteers, sponsoring agencies, sponsors, advertisers, subcontractors, owners and lessors of premises used for the activity, law enforcement agencies and all public entities and municipalities through or by which the event passes ("Releasees"), from all claims, demands, causes of actions, obligations, damages and liabilities of any nature, now and hereafter arising from or in connection with my participation in The Devil's Slide Ride, Run and Dog Walk. I agree that I will not make any claim against PARCA or any Releasees for injury or death resulting from or arising in connection with my participation in The Devil's Slide Ride, Run and Dog Walk, and I acknowledge that this release from liability is a condition of my participation in The Devil's Slide Ride, Run and Dog Walk. I further expressly waive any right or claim of right that I may have under the provisions of California Civil Code Section 1542 which provides: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release which, if known by him must have materially affected his settlement with debtor."
3. This release is in full accord, satisfaction and discharge of all claims relating in any way to my and, if applicable, my dog's participation in The Devil's Slide Ride, Run and Dog Walk and has been executed with the express intention of the extinguishments of all obligations as provided for in California Civil Code Section 1541.

4. This release shall be binding upon and shall inure to the benefit of my executors, administrators, heirs, successors and assigns.
5. By checking the box below, I agree to the waiver and release set forth herein and hereby certify that I am the registrant, I am at least 18 years of age, I have read and fully understand this accident waiver and release of liability agreement and voluntarily agree to its terms.
